**Subject: General revision of storage charges from April 01, 2023.**

Please refer to subject cited.

It is informed that as HSWC is following the pattern of CWC with regard to revision of storage charges for various commodities with some modifications, with the approval of Board of Directors of the corporation. Since the Central Warehousing Corporation has revised its general tariff of storage charges w.e.f. 01.4.2023 for various commodities by adopting the new rating of warehouses. As such, HSWC has also revised the storage charges of various commodities w.e.f. 01.4.2023, on the pattern of CWC both under Reservations and General Warehousing with some modifications in CWC storage Tariff in anticipation of BOD approval.

If any new commodity is received in the warehouses, the proposal for the same may be sent to Head Office for fixation of storage tariff accordingly.

The tariff of wheat for FCI is case of reservation (guaranteed storage for a minimum period of one year or more. The tariff decided by Ministry of CA, f & PD, Department of Food & Public Distribution, Govt. of India will be applicable for the FY 2023-24.

The revised tariff of storage charges w.e.f. 1.4.2023 is given below:

#### **AREA RATES:**

The Area Basis Tariff have been revised and in case the tariff implemented before revision of tariff is more than the revised tariff, the same are continued as per existing tariff as per CWC tariff.

The area rates per sq. feet per month when storage space is provided on 'Area Basis' are as under:

#### **(a) ACC sheet roofing godowns with truss**

- i) Gross area basis : Rs. 15.53/- per sq. feet/pm plus ad-valorem charges.
- ii) Net area basis : Rs. 23.23/- per sq. feet/pm plus ad-valorem charges.

#### **(b) Galvalume sheet roofing godowns without truss**

- i) Gross area basis : Rs. 17.11/- per sq. feet/pm plus ad-valorem charges.
- ii) Net area basis : Rs. 24.63/- per sq. feet /pm plus ad-valorem charges.

**Note:** Commodities deposited in bulk, agricultural implements, iron and steel materials i.e. pipes, sheets etc. paper and other such goods which do not have a uniform package or received without packing shall be accepted for storage on area basis.

The Storage Tariff for open area will be 60% of covered area rate in General Warehousing Segment & Export warehouse attached to CFS/ICD 75% of covered area rate for bonded Warehouse.

#### **STORAGE OF INDUSTRIAL GOODS:**

For storage of industrial goods, the warehouses are divided into four categories, i.e., Premium, Elite, Super & Normal.

The centers to be placed in these categories are also indicated below:

The premium to be charged for storage of Industrial Goods for different categories of warehouses will be as follows:-

**3. REBATE IN STORAGE CHARGES FOR AGRICULTURE GOODS and OTHER NOTIFIED COMMODITIES FOR PRIVATE DEPOSITORS :**

On the basis of present utilization of Warehouses, as per approval of BOD in its meeting dated 11.01.2023 new rebate policy have been issued vide letter No.HSWC/Business/BA-1/2023/2893-2910 dated 30.01.2023 which is as under.

Sr.No.	Details
1	20% rebate in case reservation is for 1 month
2	30% rebate in case reservation is for 2 months
3.	40% rebate in case reservation is for 3 months
4.	50% rebate beyond 3 months

**Note: Minimum one stack reservation is mandatory and the storage charges shall be realized in advance. The policy shall remain applicable upto 31.03.2024. The policy shall be reviewed afresh the financial year 2024-25.**

The rebate shall be subject to following conditions:

- (i) The occupancy level of warehouse shall be reckoned as on first day of the month of deposit.
- (ii) This rebate will not be applicable to such depositors who otherwise are eligible to rebate or concessional rates viz. Co-Operatives, FCI, CCI, FSD, HWC, Hafed, Confed, HAIC etc.
- (iii) The rebate is available on storage charges only and not on any other charges i.e. insurance/initial fumigation/supervision charges, advalorem charges etc.
- (iv) A statement showing name of the depositors, storage space utilized in MTs. and storage charges collected and rebate allowed shall be submitted to Head Office, Panchkula on monthly basis.
- (v) The rebate policy shall be open to private depositor only, throughout the year. However, this rebate shall only be allowed to those depositors who have reserved the space for minimum one month. This special rebate shall be applicable for each crop for agriculture goods and other notified commodities like cement etc. only. No rebate for Central Pool stock including paddy, wheat, Bajra or rice is admissible. Moreover, while allowing rebate/reservation, the District managers, shall use due diligence to ensure the arrangements for availability of storage space for Rabi procurement.
- (vi) Adequate storage space may be kept for Rabi Procurement and priority should be given to the central pool stocks. The left over space after procurement may also be utilized in the best possible manner by offering them to the private depositors.

4. In case of Bag Basis/SDWT Tariff, the existing applicable tariff is on weekly basis in the initial month of receipt, i.e. upto 1 week, it is 44%, upto 2 weeks, it is 68%, upto 3 weeks, it is 88% and beyond that it is full monthly tariff (as also mentioned in the SOP). The same has been revised and it has been decided that w.e.f. 1.4.2023, the tariff for lesser days than one month shall be charges on basis of actual numbers of day's utilization instead of weekly basis. i.e. for example:- if any depositor utilizes space for 20 days, then storage charges will be calculated as under:

Storage Charges= (Number of day's utilized (20) x Area Utilized or Number of Bags x Monthly Storage Tariff) / Number of days in calendar month.

For the purpose of calculating no. of days in respect of stock under storage, both the date of receipt and date of delivery are to be included while calculating the storage charges.

5. The categorization/grouping of warehouses for industrial tariff is subject to review at any time depending upon the demand and availability of storage space and in the overall business interest of the Corporation. In case, it is felt by the District Manager that any Warehouse needs to

be re-categorized for industrial tariff, he may recommend the same to the Head Office with full justification.

6. Cooperative institutions will be entitled to 10% statutory rebate and the bonafide farmers of Haryana will enjoy the rebate of 30% on Rabi produce and 50% on Kharif produce on the general tariff, subject to a ceiling of 50 MT individually for each crop for agriculture goods only. No rebate for Central Pool stocks including paddy, wheat, bajra or rice is admissible.

7. Fumigable stock e.g. Foodgrains, pulses, seeds etc. Should invariably be stored on bag basis only and not on area basis except wherever circumstances warrant with the prior approval of Corporate Office.

8. The storage charges on FCI stocks for guaranteed utilization of warehouse space will be at par with the rates payable to Central Warehousing Corporation by FCI.

9. The warehouseman shall ensure that storage charges as per general tariff are realized in full from depositors including Central/State agencies viz. IFFCO, KRIBHCO, NFL, NAFED, FSD, HAFED, HAIC, CONFED etc. before release of goods, stored in the warehouse, to the depositor.

10. In case the Corporation is having special arrangement or allotted space on dedicated basis, the provisions agreed may continue till expiry of the agreement. However, if the depositor wants to extend/renew the agreement on dedicated warehousing, then in such a situation, further extension may be considered on the basis of revised tariff as well as model agreement already circulated or the charges depositor is paying earlier as per terms including escalation agreed upon, whichever is higher.

11. In case there is a provision in the agreement that the rate will be charged as per tariff as and when revised by the corporation, in such cases the revised rate is applicable.

12. FCI Gunny Bales:- Separate bills to be generated for food grain and gunny bales stored within reserved space. The Bills for food grain stored will not attract GST, however, bills for storage of gunny bales in reserved space will attract GST.

For example; at any center FCI has reservation of 5000 MT and out of this 5000 MT capacity FCI stored 100 MT of gunny bales and 4900 MT of foodgrain, in this scenario the separate bills will be raised for 4900 MT foodgrain on reservation rates (without GST) and for 100 MT gunny bales on reservation rates (with applicable GST).

13. Tariff with regard to FCI on guarantee basis is regulated by the Ministry, based on recommendations of Chief Advisor Cost (CAC), Ministry of Finance and the same shall be circulated as and when revised.

14. Goods and service Tax/any other Tax as levied by the Central/State Govt.or local bodies, if any, will be charged extra if applicable, in addition to storage/insurance charges etc.

15. In case, any commodity has been omitted, the same may be brought into the notice of this office for taking necessary action.

16. No credit facility is allowed to State procuring agencies. However, the concessional rate of storage charges at par with FCI, shall be applicable for State procuring agencies viz. FSD, HAFED, HAIC, & CONFED for the storage of Central Pool Stock only, in case storage space is utilized by them on guarantee utilization basis for minimum one year and an undertaking is given by them to clear the arrears in the event of rate revision by FCI with retrospective effect in future. However, if the storage space is utilized by the State procuring agencies and FCI on actual utilization basis, the general tariff will be charged.

17.(i). CCI Management warehouses w.e.f 01.04.2023: The tariff for CCI management charges has been fixed at Rs. 40.00 per MT/month (GST extra) for FY 2023-24 for CCI cotton bales.

For other management warehouses concerned Regional Office should submit a detailed proposal for fixing the revised rate of storage charges.

(ii). CCI Hired Godowns w.e.f. 01.04.2023: The tariff applicable for own godowns will be applicable for hired godowns also in case of CCI but with a maximum cap of Rs. 66.83 per bales per month.

18. To ensure optimum utilization of capacity, minimum stack height shall be maintained as under:
